Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by E-Auction service provider (may take 2 working days), the intending Bidders/ Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet before the E-Auction Date and time in the portal.
